Kids Walk and Fun Run prior to the "main event" taking place at 1 p.m.

The streets between the start and finish were filled with vendors and activities and people from all over the region and beyond came decked out in their green to celebrate the holiday weekend.

Three different waves of runners went off at the start, with more than 5,000 participants in the first Road Race since 2019 to take place.

With just a week before it was supposed to take place, the race was cancelled in 2020 when the world basically shut

itself down for a few weeks that ended up being months. A spike in COVID-19 cases along with vaccines not widely distributed led to the cancellation of the 2021 race.


But in 2022, it was Malcolm Connor, 27, of New Haven, Conn., that was crowned the first post-pandemic winner of the annual event. He finished the 6.3-mile course that has been described by participants as very "hilly" in 31:46.

There was a bit of rain at the start of the race, but otherwise, harriers only had to deal with occasional mist and drizzle that remained lights throughout the two hours finishers were recorded. More than 3,100 were recorded to have finished the

The top female in the race was Jenna Gigliotti of Amherst. She finished 11th overall with a time of 34:30.

Rounding out the top five was Stephen Fondakowski of Pelham, NH., Wilson Tuwei of Holyoke, Ryan LaFrance of Gilford, NH, and Christopher Vayda of Southampton. Fondakowski finished at 32:01, Tuwei at 32:38, LaFrance at 33:07, and Vayda at 33:14.

The race continued traditions of participants running for various charities and other causes, in honor of deceased loved ones, and of course, the running of the race in costume.
