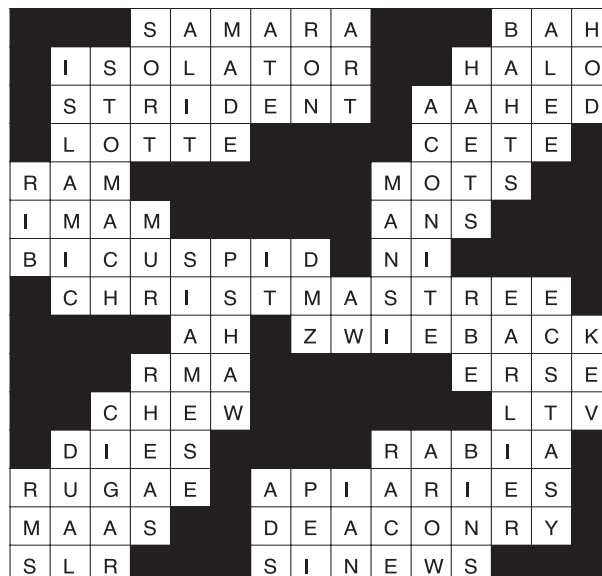
Town Reminder OBITUARY POLICY
